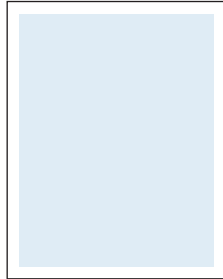

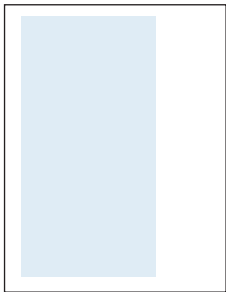

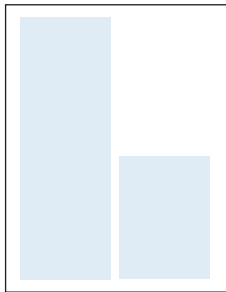

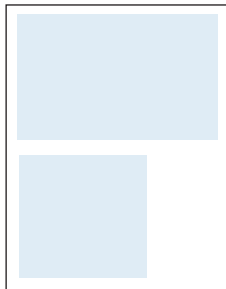

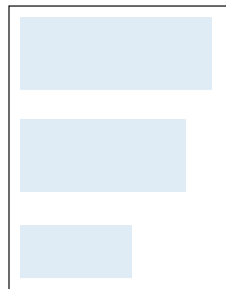

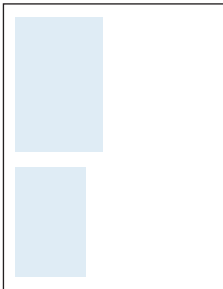

PAYMENT
